Sommersett s^r: Francis Jenckins was summoned to answer unto William Walston as y^e attorney of Thomas Jones of Bristoll Merchant in an action of y^e Case or Whereupon y^e said William Walston by his attorney Thomas Cook saith in this present year one thousand six hundred seventy five in or about y^e month of May last past: Capt^a: Thomas Jones did make an agreement with him y^e said William to weatherboard & cover a dwelling house of y^e said Capt^a: Jones in Manakin river & also to provide & gett y^e boards for y^e which getting of y^e said boards y^e s^d Capt^a: Jones was to pay y^e said William for each thousand of boards four hundred & fifty pounds of Tobacco there being two thousand of boards rived & drawn by y^e said William which am^t to nine hundred pounds of Tobacco y^e said house being finished accordingly there being due to y^e plaintiffe one thousand three hundred pounds of Tobacco Now Francis Jenckins y^e attorney of Capt^a: Jones denyeth payment wherefore y^e plaintiffe traveth order ag^t Francis Jenckins as y^e attorney of Capt^a: Jones for y^e said 1300^l of Tobacco with Cost of Suit:

John King and Andreio Whittington appears on y^e part of y^e p^l: and were examined upon their oathes & the said Francis Jenckins being then there alledging nothing to y^e contrary wh^{ch} he should not pay the same this Court finding that there is due to y^e plaintiffe from Capt^a: Thomas Jones one thousand three hundred pounds of Tobacco doe order that Francis Jenckins attorney of Capt^a: Thomas Jones pay unto y^e plaintiffe W^m: Walston or his order one thousand three hundred pounds of Tobacco out of y^e Tobaccos in his hands of Capt^a: Thomas Jones with Cost of Suit alias execution: /
