Whereas an Attornment was granted by this Court to Robert Catin Sen^r upon the goods Chattels debts & Credits of Cornelius Verhoof for nine hundred forty five pounds of tobacco the Sheriff having laidy Attornment for the said 945^l of tob. in the hands of Alle pander Draper of this County gent^l to answer the debt of Robert Catin in ap^{pl}ca of debt And the def^t ^{Cornelius Verhoof} not appearing either in person or by his attorney; This Co^{ty} therefore orderd that Alle pander Draper pay unto Robert Catin Sen^r or his order the said nine hundred forty five pounds of tobacco in cash by November Court next Alias execution /
