 happen to be done & perpetrated in y^e County aforesaid against y^e laws and orders of our said province
 provided you proceed not in any cases aforesaid to take life or member But if in any such case
 you send y^e prisoners with their indictments & y^e whole matter depending before you to the next
 provincial Court to be holden for our said province whensoever or wheresoever to be holden there
 to be tried and further we doe hereby authorize you to issue writts proceffe arrests & attachments
 to hold plea of Oyer & Terminer & after judgment execution to award in all cases Civill whether in
 actions real or personall where the thing in action doth not exceede y^e value of three thousand
 pounds of tobacco according to y^e laws orders & reasonable usages made & used in our said province of
 Maryland in which cases Civill doe to be tried we doe constitute ordaine & appoint you W^m Stevens
 W^m Colebourne & James Jones John White Thomas Walker & George Johnson to be judges as
 aforesaid (unless some other one of our counsell be then in Court) and therefore we command you that
 you diligently intend y^e keeping of y^e peace laws & orders & all & singular other y^e premises & con-
 taine daies appointed according to act of assembly in that case provided & such places as you
 or any four or more of you as aforesaid shall in that behalfe appoint yee make enquires upon y^e
 premises & performe and fulfill same in forme aforesaid doing therein that which to justice
 appertaineth according to y^e laws orders & reasonable usages of our said province savinge to us
 y^e amerciaments & other things to us belonging; And therefore we command y^e Sheriff of the said
 County of Somerset by vertue of these presents y^e at y^e daies & places aforesaid which you or any such
 four of you as aforesaid shall make knowne to him to give him attendance on you And if need require
 to cause to come before you or any such four or more of you as aforesaid such & soe many good & law-
 full men of your County by whom y^e truth in y^e premises may y^e better be knowne and enquired off
 And further you shall cause to be brought before you at y^e said daies & places y^e with proceffe
 proceffe & indictments to yo^r Court & jurisdiction belonging that y^e same may be inspected & by a
 due course determined as aforesaid Given at the City of S^t Maries vnder our great scale of our pro-

 assigns for ever two Steers one of two yeares old & the other three both Copt of y^e left car
 and three flitts in y^e Copt and doe for ever warrant & defend y^e said sale of Cattle from all persons
 whatsoever as witnesses my hand & scale this thirde day of August one thousand six hundred
