son William attineth to my age of eighteen years & my daughter Sarah to my age of fourteen years shal be
have and hold both male & female to enjoy & dispose of as their proper goods forever to bee equally
divided between them these cattle with my mare foal to runn in a stock amongst Richard Stevens of this
County of Somerset & province of Maryland for my only proper inheritance of my said Children aforesaid
tended until they come to my above recited age if in case one of my said Children shal be taken
away by death before his or her attaineth to my age above recited then my survivor to enjoy the whole
and if in case both should die before their coming to my age aforesaid then my said Cowes & mare
foal to bee returned to me their mother againe with their inheritance to bee after disposing more
over it in my will & pleasure at none of my aforesaid Children shall dispose of any of what is given
them or their inheritance until they come to my age before recited without my consent or their guardians
