Knowe all men by these presents y^e Anne Averiij of ij Cittie of Bristol widowe relict & administratrix
with ij last will Annexed of all & singular the goods & Chattells rights & Credits which were of Emannell
Averiij late of ij Cittie aforesaid Mariner deceased have made ordained constituted authorized and
appointed & by these presents in my place & stead doe putt Thomas Whittop of ij said Cittie
Mariner my true & lawfull attorney for mee and in my name & to y^e use of y^e last will aforesaid to
demand & receive of James Jones of Maryland all & every debts due summes & summes of money goods
wares & merchandizes which were due owing or belonging to y^e said Emannell Averiij in his life time
or which are due owing or belonging to mee as administratrix of y^e said Emannell Averiij or otherwise
howsoever & if occasion require to sue arrest attaint implead imprison & prosecute y^e said James
Jones & to use all lawfull waies & means for y^e obtaining & recovery of y^e premises according to y^e law
usage & custome of ij Countie & upon receipt thereof acquittances & lawfull discharges for mee &
in my name to make give seal & deliver one or more attorney or attorneys in y^e premises to make
& substitute & y^e same againe att his will & pleasure to revoke giving & by these presents granting
to my said attorney my good right full power & lawfull authoritie to doe & performe all & whatsoever
shall bee requisite to bee done in y^e premises ratifying allowing & holding firme & stable all &
whatsoever my said attorney shall lawfully doe or cause to bee done in y^e premises to bee as good and
effectuall in y^e law to all intents & purposes as if I had done y^e same in my owne person In witness whereof
I have hereunto sett my hand & seal dated this one & twentieth day of August in y^e eight & twentieth
yeare of y^e reigne of o^{ur} Sovereigne Lord Charles y^e second by y^e grace of God King of England A^o 1676.
