Whereas Mary Wilson by herselfe in her owne person appeareth before y^e Co^t: sheweth that shee her freedom she having y^e s^d s^rvice finished y^e time of servitude with M^r. W^m: Breerton & produceth this following indenture w^{ch} is read vizt: This Indenture made y^e sixteenth day of October: in y^e year of o^r Lord one thousand six hundred seventie two Betweene Mary Wilson of y^e one part y^e & Anthony Alderson of y^e other part: Witnesseth y^e s^d Mary Wilson doth hereby Covenant promise & graunt to & with y^e s^d Anthony Alderson his ex^{ec}uto^r & assignes from y^e day of y^e date hereof until her first & next arrivall att Virginia after for & during y^e terme of four yeares to serve in his s^d s^rvice & employment as hee y^e s^d Anthony Alderson or his assignes shall thinke employ her in according to y^e custome of y^e Countie In y^e like kinde; In consideration whereof y^e s^d Anthony Alderson doth hereby Covenant & graunt to and with y^e s^d Mary Wilson to pay for her passing & to finde & allow her meat drink apparell & lodging with other necessaries during y^e s^d terme & att y^e end of y^e s^d terme to pay unto her one yeares provision two suites of apparell & one hundred acres of land according to y^e custome of y^e Countie In witness whereof y^e parties abovesaid to these Indentures have interchaungably sett their hands & seals y^e day & yeare above written: l: Anthony: Alderson: Seal:

The Dutty merchant M^r. Thomas Penij master arrivd in y^e Cape of Virginia y^e 14th day of Dec^r: in y^e year: 1672 And the s^d M^r. Breerton by himselfe in his owne person Cometh & defendeth: & saith that shee went by y^e name of s^d Breerton knowing nothing of an Indenture & therefore requies her s^d s^rvice for five yeares in this Co^t: order y^e the s^d Mary Wilson remaine in s^d s^rvice with M^r. W^m: Breerton until next Cometh & then if M^r. W^m: Breerton cannot make appeare by sufficient assignement y^e s^d s^rvice was to serve five yeares or by his oath upon y^e holy Evangelist shee was to serve him 4 yeares then y^e s^d Breerton to allow her for overplus of s^d s^rvice:

Sommes set s^d Coll^{er}: William Colebourne of this Countie was summoned to answe^r unto John Ziffer Carpenter in an action of y^e case & And whereupon y^e s^d John by his attorney Thomas Poole saith y^e s^d Colebourne became indebted unto him y^e s^d 21st february last past in y^e year Annoq; Domini 1676 the full & just summe of two thousand one hundred & ninetie pounds of tobacco & casq; as p^{ro} attempt here in Co^t: produced more plainly will appeare but hee y^e s^d Colebourne fraudulently intending to deceive him y^e s^d Ziffer of y^e aforesaid summe of 2190 of tobacco in caske devised & still doth deny to pay y^e aforesaid summe although often therunto required y^e p^{er} saith y^e hee is damnified & shall damage to y^e value of two thousand nine hundred pounds of tobacco & casq; & thereupon brings his suit: l: s^d Ziffer: & h^o: Poole: l:
