Davison doth bind out his daughter Jane Davison unto W^m: King for seven years & ij^s said
King doth engage to maintaine ij^s said Jane Davison in meate drink & apparel & ij^s said
W^m: Davison doth engage himselfe not to take his daughter away from W^m: King And ij^s
King will bring ij^s said Jane Davison to doe ij^s worke in ij^s house & to make her owne linnen
And for consideration when ij^s said Jane Davison hath served four years ij^s said King will
reward a keifer Calfe for ij^s use of Jane Davison & soe run on for ij^s good of ij^s girts male
& female given from under our hands this 30th of March 1675:

acquitt & discharge & release Henry Boston of my third part of this moveables goods
being due unto me for my third alsoe I doe discharge ij^s said Henry from all debts
& attempts whiche I ij^s said Elizabeth ever had unto this day onely I doe except my third
part of ij^s lands to bee due unto mee still ij^s summe of my third amounting to twentij
one thousand nine hundred & twentij pounds of Tobacco in witness hereof I have
herunto put my hand & fixed my seal this 1st day of May 1677:

for ij^s said County of Sommersett & ij^s whole paym^t well & kinclij to bee made we binde our
selves & our heires by this selfe Jajment & severally for ij^s whole and in the whole our &
