And whereupon the p^lt by Thomas Look his Attorney Comes and saies That he the said Mason in the year of o^r: Lord 1602 became indebted unto y^e p^lt the full & Just Summe of Three Thousand one hundred & fiftie pounds of Tobano & Cash to containe y^e same it being due to the p^lt for severall goods & marchandizes delivered by the p^lt unto the def^t at y^e an^o: here in so^o produced with more plainly appeare the which An^o: the def^t did faithfully promise to pay and satisfie unto the p^lt when thereunto required but he the said Mason lett^e regarding the promise but fraudulently misled the p^lt to detaine of the Summe aforesaid of 3005^o of Tobano doe denie & still doe deny to pay the same although often hereunto required by the p^lt whereupon the p^lt saies he is damaged & hath damage to the value of 5000^o of Tobano & thereupon brings this Sute
