Chas Condicon Being such that if the above named John Lamp shall and will be of the good  
behaviour towards all his Lorde p[er]sones good people as also will make his personall appearance  
Every year during pleasure and that he will pay all officers fees due from him that then  
the above Obligation to be void otherwise to remaine in full force.

The Juro<sup>r</sup> for the R<sup>t</sup> hono<sup>r</sup> the Lord prop<sup>r</sup> B<sup>r</sup>ing Sworne upon the holly Evangelist at a  
grand Jury held for the body of this County the second Tw<sup>o</sup>-day in November last past Yrs,  
present and find that Lawrence Young upon the Sabbath day of the Month anno Domini 1886  
in weeding time most Atheistically wickedly and profanely did vilify & blasphemous  
God Almighty and did openly declare that the holly and sacred Word of God contained in the  
Bible known by the name of the Old and New Testamente was false and not one word of  
Truth in them w<sup>t</sup>. Said Young was so wicked as to declare and publish w<sup>t</sup> said atheisticall  
Exp<sup>r</sup>ession the Devilish thows<sup>t</sup> he do<sup>d</sup> dare not to Express as denying the religion of plauso<sup>r</sup>  
and made manifest in the said Word whereby he hath declared himself an enemy to  
God that gaved him life and breadth our Savio<sup>r</sup> Jesu<sup>r</sup> Christ and Salvacion by him and the  
holly Ghost that inspired the holly w<sup>r</sup>ds of God to give forth the word Wherefore his Lord pp<sup>r</sup>  
Attourney General may present ag<sup>t</sup> the said Young according to the moritt of the said

Upon which said Lawrence Young in his proper person and pleaded not guilty & for his

Lawrind Young into Custody and that on his Bond back w<sup>t</sup>e laid on he give him  
Ships which were specified as also that the said Lawrind Young give good sufficient  
Security as w<sup>t</sup>e for his behavio<sup>r</sup> as for his appearance every Court during pl<sup>t</sup> a few
