the first bill one hundred bushells to be p^d on the 10th day of October in y^e year of our Lord 1673 the
second two hundred bushells payable upon the 10th day of October in y^e year of our Lord
1674 the third bill fifty bushells of wheate but he the said John little regarding his said
promise or assumption but fraudulently intending the p^{te} to receive of the aforesaid
Three hundred & fifty bushells of wheate doth come & still doth come to pay the same
although often then unto required by the p^{te} where upon the p^{te} saith he is damaged &
hath damage to the value of seven hundred bushells of the said wheate and there upon
bringe this suit /
