And Whereupon the pl^t by Thomas Laramore his Attorney saith that he the said Thomas did covenant & agree to & with the pl^t predecessor as well in Court more plainly appeared as of agreement under the hand & seal of him the said Thomas bearing date the sixteenth day of December in the year of our Lord God 1681 the which Agreement was here in Court to produce but he the said Thomas being careless & negligent in performance of his agreement did neglect in the time of living upon the said land the performance of Agreement in severall Articles of the said Condition & since doth refuse to comply with the aforesaid Articles whereupon the pl^t saith he is Damified & hath Damages to the Value of six thousand pounds of Debt & thereupon brings his suit

And the def^t Thomas Laramore by his Attorney, Isaac Haugster. saith that he the said Thomas doth pray liberty to appear hereunto till the next County Court & it is granted to him the same day is granted to the pl^t as for

Now here at this day (to wit) the 12th day of September as aforesaid saith the said parties by their Attorneys aforesaid and the said Thomas by his Attorney saith that the said pl^t his action he ought not to have because that the said Alexander declared upon breach of covenant & hath not said the breach of said Article & therefore cannot tell what Article he declared upon, his declaration being so general

And the said Alexander saith that he ought not to be debarred his action aforesaid
