 redress to pray & require before by or from any Lord Justice or other Lawfull authority
 and upon receipt of any such Debt Summe of money or other estate whatsoever due
 as abovesaid acquitt me and discharge for my selfe & Company & in my name to
 make seal & deliver giving & by these presents granting to my selfe attorney my selfe
 full power strength and authority to doe say performe & finish all & every such
 thing that shall be requisite & convenient whatsover in the Law needfull to be done concerning
 the premises in as full & ample manner as I might or could doe if personally present
 Attorneys one or more under him my selfe attorney with like power to make & substitute
 as at pleasure to me or me my selfe attorney I doe hereby Covenant to Ratify & Confirm all & what
 my said attorney or his substitute shall Lawfully doe or cause to be done concerning
 the premises by vertue of these presents In witness whereof I have hereunto set my hand
 and seal the thirteenth day of April one thousand six hundred & eighty seven & in the
 third year of the Reigne our Sovereigne Lord King James the second of Great Brittain
