BY THE SENATE, DECEMBER 1, 1800.

RESOLVED, That the governor and council be and they are hereby authorifed and requested to direct the surveyor of Cæcil county to survey, at the expence of George Gale, of said county, all that tract or parted of land, being part of new Connaught manor, lying in Cæcil county aforesaid, which was purchased by a certain John Ryan, of said county, of Daniel of Saint Thomas Jeniser, then intendant of the revenue of the state of Maryland, and by the said John Ryan conveyed to the said George Gale, by a deed executed on the sirst day of December, in the year of our Lord seventeen hundred and ninety-sive; and that the chancellor of the state be and he is hereby authorised and requested, on certificate of survey being returned to the land-office of the western shore by the said George Gale, and the sum of eight shillings and nine-pence per acre, with interest thereon from the time it was sold by the said intendant, being paid into the treasury for the tract aforesaid, to issue patent to the said George Gale for the same.
