RESOLVED, That the fenators of this state in the congress of the United States be and they are hereby requested, to use their best endeavours that congress propose to the legislatures of the several states the following amendment to the federal constitution, to wit: The congress may, from time to time, divide each state into as many districts, for the purpose of choosing electors of president and vice-president of the United States, as shall be equal to the number of electors such state may be entitled to elect.

RESOLVED, That the prefident of the fenate and the speaker of this house be requested forthwith to transmit, the foregoing resolve to the senators of this state in congress; and that the governor and council be and they are hereby requested to communicate the same to the supreme executives of the several states, with a request that they may be submitted to the consideration of their respective legislatures.
