On motion, Leave given to bring in a bill to authorize Benjamin Ray, junior, to collect the balances due him as sheriff and collector of Montgomery county. ORDERED, That Mr. T. Davis, Mr. Magruder and Mr. Quynn, be a committee to prepare and bring in the same.

A petition from Lewis Duvall, of Montgomery county, praying an act of insolvency, was preferred, read, and referred to the committee appointed on the petition of Chamberlaine and Magruder.

Mr. Quynn, from the committee, delivers to the speaker a bill, entitled, A supplementary act to an act to lay out and establish a road from the city of Annapolis to the city of Washington, and to repeal the act therein mentioned; which was read the first time and ordered to lie on the table.

The report on the petition of the securities of Dennis Griffith was read the second time, and the question put, That the house assent to the resolution therein contained? The yeas and nays being required, appeared as follow:
