III. AND BE IT ENACTED, That the faid commissioners may appoint one of their number as treasurer, and give him a certificate, under their hands, of his appointment, who is hereby enjoined and empowered to collect and receive all monies subscribed, or that may be subscribed, for the purpose of opening the said road, and such subscribers are hereby directed to pay their several sub- rer, &c. criptions to the treasurer appointed as aforesaid; and if any person shall neglect or resuse, when applied to by the aforefaid treasurer, to pay his subscription money, the said treasurer may, and he is hereby authorised to sue for, recover and receive, the same; and the said monies, when received, shall be applied by the commissioners, or any two of them, to the purpose of this act.

IV. AND BE IT ENACTED, That the commissioners aforesaid shall ascertain and value what And ascertain damages may be fustained by any person or persons through whose land the said road may pass, by damages, &c. opening the same, and the said valuation shall be made before the said commissioners shall proceed to open the same; provided always, that if any person or persons through whose land the said road shall pass, or his, her or their guardian or trustee, shall conceive themselves aggrieved by such valuation and affestment of damages by the faid commissioners, it shall and may be lawful for any justice of the peace of the said county of Frederick, on application of the party interested, to issue his warrant, under hand and feal, directed to any constable of the county, commanding him to summon five freeholders, difinterested as to the faid road, to appear, on a day by him to be appointed, on the land of the person making application as aforesaid, and the said freeholders, having first made oath before some justice of the peace, that they will, without favour, affection, prejudice or partiality, affects the damages fustained by the person or persons at whose request such inquisition shall be taken, by reason of opening the aforefaid road through his, her or their land, shall thereupon proceed to affess and value the damages accordingly, of which the faid commissioners shall have had at least five days previous notice, and shall return the damages so assessed to the said justice of the peace, and such inquifition and valuation shall be final and conclusive; and the party or parties in whose favour the valuation ascertained by the said commissioners, or the damages assessed by the said freeholders, shall be made, shall be entitled to receive the same from the said commissioners; and the said commissioners shall pay, or secure to be paid, the amount of the said valuation or damages to the respective parties entitled to the same, out of the monies to be raised and collected from the subscriptions to the said road, within the space of fix months after the affessment of such valuation or damages, and before they shall proceed to affect the lands and tenements of the person or persons concerned; provided. that the faid road shall not go through any houses, gardens, yards, meadows or orchards, unless with the consent of the owner thereof.

C H A P. LXXIII.

An ACT to extend the powers of the trustees of the poor of Mont- Passed 19th of Dec. 1800. gomery county.

HEREAS Elizabeth Gates, by her petition to this general affembly hath fet forth, that she Freamble. is now in the ninetieth year of her age; that from her advanced age and bodily infirmities the has for a number of years been unable to support herself, and hath no means whereby to subsist. but on the benevolence of her daughter, who is very poor, and prays that an act may pass to provide for her future maintenance out of the poor's house; therefore,

II. BE IT ENACTED, by the General Assembly of Maryland, That it shall and may be lawful for the E. Gates to be trustees of the poor of the faid county of Montgomery, if they shall be of opinion that the peculiar supported, &c. circumstances of the said Elizabeth Gates are such as to render a situation in the poor-house particularly unfuitable for her, to support her as an out-pensioner, in addition to the number now allowed by the act, entitled, An act to enlarge the powers of the truffees of the poor in the feveral counties therein designated, and to allow to the said Elizabeth Gates an annual pension, not exceeding thirty dollars, to be paid at such time or times as the said trustees shall direct, the amount of which said pension shall be levied in the same manner as the other expences of the poor-house in the said county.

C H A P. LXXIV.

An ACT to levy on the affessable property of Anne-Arundel county Dec. 1800. a sum of money for the purpose herein after mentioned.

HEREAS by an act of affembly, passed at November session, seventeen hundred and ninety- Preamble. one, entitled, An act to lay out certain roads in Anne-Arundel and Montgomery counties. it was enacted, that one road through Anne-Arundel county, from the turnpike road in Baltimore county, until it interfects the road from Frederick-town at the line of Frederick county, near Wil-
