III. AND BE IT ENACTED, That the justices of the levy court of Prince-George's county are hereby authorifed and directed to levy the fum of five hundred dollars, to enable the commissioners Justices to levy to carry this act into execution; and when the faid road shall be completed, the faid commissioners inoney, &c. shall settle their accounts with the levy court of Prince-George's county, and pay over the balance, if any, that may remain in their hands, and the balance shall be by the levy court applied to the use of faid county.

An ACT to aid and amend defects in the records, papers and pro-Paffed 19th of Dec. 180c. ceedings, in the register of wills office of Harford county.

BE IT ENACTED, by the General Assembly of Maryland, That all letters testamentary, all letters of Letters, &c. to be recorded, administration, all testamentary bonds, all administration bonds, all inventories, and all guardians &c. bonds, and all accounts of sperate and desperate debts, and accounts of sales, not heretofore recorded in the office of the register of wills in Harford county, and which shall be hereafter filed in faid office, shall be fairly recorded by the register of wills of faid county in folio books, well bound, with a correct and fair index to the fame.

II. AND BE IT ENACTED, That all wills, heretofore recorded and certified by the late register of Wills to be wills of faid county to have been proved according to law, although fuch probat and certificate are good, &c. not in due form of law, and have not been endorfed on faid will in words at length, or recorded inwords at length, or figned by the late register, shall be as good, valid, and of the same avail in law, to every intent, as if the faid probat and certificate had been endorfed on faid will, and figned by the late register, and recorded in due form of law.

III. AND BE IT ENACTED, That all inventories, accounts of sperate and desperate debts, and Inventories, accounts of fales, heretofore returned to and filed in faid office, upon which the oath prescribed by &c. to be good, law has not been endorfed and certified, and figned by faid register according to law, and which have &c. not been duly recorded, shall be and are hereby declared to be as good and available in law as if the faid oath endorsed and certified thereon had been in due form so recorded.

IV. AND BE IT ENACTED, That all errors in casting up figures in any account heretofore render- Errors may be ed, and in any inventory heretofore filed, shall and may be corrected by the register of wills, under corrected, &c. the directions of the orphans court of faid county.

V. AND BE IT ENACTED, That in all cases where inventories, accounts of sperate and desperate Court, in cerdebts, and accounts of fales, have been filed, and no fort of probat and certificate endorsed on the tain cases, to fame, that the orphans court aforefaid shall and may issue a citation for the executors or administrators, or their survivors, personally to appear before said court, and make oath agreeably to the form prescribed by law.

VI. AND BE IT ENACTED, That in all cases where an account of sales has not been returned to And also issue faid office, and the executors and administrators are not deceased, and where there are survivors, the process, &c. faid orphans court shall and may issue process to compel the faid executors and administrators, or their survivors, to return in due form of law a regular account of sales.

VII. AND BE IT ENACTED, That all testamentary bonds, all administration bonds, and all Bonds, &c. to guardians bonds, filed in faid register's office, being in the hand writing of the faid late register, but be good, &c. not figued by him, or any other person as a witness, shall be as good, and of the like avail in law, as if the same had been signed by the said late register as a witness.

VIII. AND BE IT ENACTED, That in all cases where wills have heretofore been filed in said re- Probats to cergister's office, and not proved according to law, and the witnesses thereto are deceased, that probat tain wills to be of the hand writing of the witnesses, and of the testator, or probat of the actual execution of said good, &c. will by any other competent witness or witnesses, made in the faid orphans court, shall be as good, and of the like avail in law, as if the faid will had been heretofore duly proved in the faid orphans court, in the form prescribed by law, which said probat shall be endorsed on said will, and certified by the register of wills, and recorded as other probats of wills are endorsed, certified and recorded.

IX. AND BE IT ENACTED, That the register of wills of Harford county shall be entitled to charge Register's sees, and receive the same fees for doing the duties herein prescribed as he is entitled to receive for like &c. fervices;
