No. 150. An Act to authorize the Governor to appoint ten additional Notaries Public for Baltimore City.....	192

An Act to provide for an extra levy by the Mayor and Council in Salisbury, Wicomico County, for the purpose of refunding taxes erroneously paid on tax levies for the years 1897 and 1898, and to pay the indebtedness of the Mayor and Council of Salisbury incurred by reason of the inability to collect the illegal levies of the said years 1897 and 1898, and to be designated as Section 158A of the Code of Public Local Laws of Maryland, title "Wicomico County," sub-title "Salisbury," and to follow Section one hundred and fifty-eight of Article 23.....	195

An Act to amend the Charter of the American Bonding and Trust Company of Baltimore City, and to repeal and re-enact with amendments Section three of Chapter two hundred and fifty-two of the Acts of eighteen hundred and ninety-four, incorporating said company under the name of the "American Banking and Trust Company of Baltimore City," and to repeal and re-enact, with amendments, Sub-section two of Section one of Chapter forty-one of the Acts of eighteen hundred and ninety-six, amending the Charter of said company, and changing its name to that of "The American Bonding and Trust Company of Baltimore City," and to increase the capital stock of said company, and to enlarge the powers of its officers.....	197
