No. 239. An Act to regulate the mode of payment of all appropriations made by the State to any association or incorporated institution maintained for industrial, educational, medical, humane, military or charitable purposes..... 356

No. 240. An Act to provide for the annual compilation and publication of a Manual of the State of Maryland..... 357

No. 241. An Act to refund to Caleb H. Price certain moneyspent by him to defend himself in a criminal prosecution, the cause of which happened while acting as a deputy officer of the Oyster Police Force of the State of Maryland..... 359

No. 242. An Act to authorize the County Commissioners of Carroll County to issue bonds to liquidate the indebtedness of the School Commissioners of said county..... 359

No. 243. An Act to authorize the Board of Police Commissioners of Baltimore City to increase the pension of John Steindler, retired policeman of the Police force of Baltimore City..... 361

No. 244. An Act to provide for the division of the first election precinct of the fourteenth election district of Baltimore County into two election precincts to be known as Precinct No. 1 and Precinct No. 3, respectively..... 362

No. 245. An Act to repeal and re-enact, with amendments, Sections one and three of Chapter five hundred and forty, of the Acts of the General Assembly, eighteen hundred and ninety-four, being an Act to authorize the Great Falls Power Company to erect dams, hold real estate, and to erect and maintain lines for the transmission of electricity in Montgomery and Prince George's Counties, in the State of Maryland, and to add an additional section thereto, to be called Section 3A, and to grant certain additional powers, rights and privileges unto the said Great Falls Power Company..... 363

No. 246. An Act to repeal and re-enact, with amendments, Sections two and three of Chapter five hundred and ten of the Acts of eighteen hundred and ninety-eight, entitled an "Act to incorporate the Continental Trust Company..... 365

No. 247. An Act to consolidate the corporations known as the Trustees of the Methodist Episcopal Church, called the Eden Chapel, and the William Watters Memorial Methodist Episcopal Church of Harford County, and to enlarge the powers of the consolidated corporation ..... 367

No. 248. An Act to amend the charter of the Susquehanna Power and Paper Company of Harford County, a corporation organized under the Public General Laws of the State of Maryland, to enlarge its powers and to change the corporate name thereof by omitting therefrom the words of "Harford County"..... 369

No. 249. An Act to provide for fixing license and penalties for hucksters, dealers, brokers or middlemen of unbaled hay, unbaled straw or ear corn by the wagon load in Baltimore City..... 372
