No. 335. An Act to refund to Calvin Satterfield and Lawrence Satterfield, executors of William C. Satterfield, late of Caroline County, the sum of one hundred and nine dollars and seventy-eight cents for taxes erroneously collected from the said William C. Satterfield, and paid into the Treasury of the State.....	506
No. 336. An Act to prohibit the Clerk of the Circuit Court for Talbot County from issuing license to any person, company of circus riders or equestrian performers, or to any person or company to exhibit for reward any animal or animals or natural or artificial curiosities (except models of useful inventions) during the months of August, September and October in any year, (except to fair associations or persons authorized by them), and providing penalties for such unlicensed exhibitions.....	506
No. 337. An Act to repeal and re-enact with amendments Section thirty-one, of Article 43, of the Code of Public General Laws of Maryland, title "Health," sub-title "Infectious Diseases—Small-pox," and provide for the free vaccination of pupils in the public Schools of this State.....	507

An Act to empower the Mayor and Common Council of Westminster, in Carroll County, to call in the bonds of the City of Westminster, issued by authority of Sections 248, 249, 250 and 251, of Article 7, of the Code of Public Local Laws of the State of Maryland, and to raise money therefor by issuing other bonds of said city.....	509

An Act to repeal Section forty-one and the sections thereafter to Section eighty three (but exclusive of Section eighty-three) of Article 10 of the Code of Public Local Laws, title "Dorchester County," sub-title "Cambridge," together with all other sections and sub-sections under and belonging to said sub-title "Cambridge," (whether said sections or sub-sections are embraced in the Code of Public Local Laws, as enacted by the General Assembly at the January Session, in the year eighteen hundred and eighty-eight, or whether they have been passed since the January Session of said year), saving and excepting the sections and sub-sections of said sub-title "Cambridge," which are in this Act specifically saved and excepted from repeal, and to enact, in the place and instead of, and as a substitute for, the sections and sub-sections, which are by this Act repealed, the sections and sub-sections which are hereinafter set forth under the sub-title "Cambridge," as a sub-title of Article 10 aforesaid. An Act to repeal and re-enact, with amendments, Sections numbered 140, 141, 142, 143, 144, 145, 150, 151, 152, 155, 156, 157, 158, 159, 163, and 175, of Article 13 of the Public Local Laws of Maryland, title "Harford County," sub-title "Havre de Grace," (said Sections 142, 143, 145, 150, 152, 155, 156, 157, 158, and 159 having been heretofore repealed and re-enacted by the Act of eighteen hundred and ninety, Chapter one hundred and eighty),
