No. 409. An Act to prohibit the County Commissioners of Baltimore County from spending or appropriating any greater sum of money than they shall have levied upon the taxable basis of said county, for the current expenses of said county, for the ensuing year for which said levy is made.....	691
No. 410. An Act to refund to Achilles Ford, brother of William G. Ford, late of Baltimore City, deceased, a sum of money erroneously paid as collateral inheritance tax by him to Stephen R. Mason, Register of Wills of Baltimore City, on the estate of said William G. Ford, deceased, and which sum of money was covered into the State Treasury by said Register of Wills less twenty-five per centum commission retained by him.....	692
