

No. 580. An Act to add four new sections to Article 11, of the Code of Public Local Laws, title "Frederick County," under the new sub-title "Mount Pleasant," to follow Section three hundred and seventy-three of said Article, and to be known as Sections 373A, 373B, 373C and 373D, being an Act to prohibit the running at large and pasturing of live stock along the turnpike which runs through the village of Mount Pleasant, Frederick County, Maryland..... 908

No. 581. An Act to repeal Section ten, Article 26, of the Code of Public General Laws of Maryland, title "Courts," sub-title "Appointment of Surveyor," and re-enact the same with an amendment..... 909
