The amendments to the bill for the opening of Second-street in the city of Baltimore, were read the second time, agreed to, and the bill ordered to be engrossed.

The bill to prevent unnecessary delay and expence, and for the further advancement of justice in the court of chancery, was read the second time, passed, and sent to the senate by the clerk.

The bill to incorporate a society for the maintenance and education of poor female children, by the name of the Benevolent Society of the City and County of Baltimore, was read the second time, passed, and sent to the senate by the clerk.

A petition from William Hammond, and others, securities of Dennis Griffith, praying to be released by the state from their securityship, was preferred, read, and referred to the committee appointed on the petition of Dennis Griffith.

Mr. Hyland, from the committee, brings in and delivers to the speaker a bill, entitled, An act for the relief of James Roney, of Somerset county; which was read the first and second time by especial order, passed, and sent to the senate by the clerk.

On motion, Leave given to bring in a bill to provide for the administration of justice in cases of crimes and misdemeanors in the city and county of Baltimore.
