THE committee to whom was referred the petition of Thomas Owings, of Baltimore county, report, that they have taken the same into consideration, and are of opinion that commissioners should be appointed to examine and survey the private road, as laid down for the use of Thomas Owings by Thomas Gift, Esquire, surveyor, as also to take into their consideration whether the same hath been, under all circumstances, carried in the most suitable and proper direction, and if it should be the opinion of the said commissioners that the said private road has not been carried in the most suitable and proper direction, under all circumstances, that they should have an authority to lay off the same anew, agreeably to the spirit and intention of the act of assembly passed at November session, seventeen hundred and eighty-five, chapter 49, entitled, An act to declare and ascertain the right of citizens of this state to private roads or ways.

Mr. Wright, from the committee, delivers to the speaker a bill, entitled, A supplement to an act, entitled, An act authorizing the justices of the levy court of Queen-Anne's county to levy a sum of money for the building of a prison in the said county, and to regulate the same; which was read the first and second time by especial order, passed, and sent to the senate by the clerk.
