Mr. J. Buchanan, from the committee, delivers to the speaker a bill, entitled, An act for the relief of John Johnson of Washington county; which was read the first time and ordered to lie on the table.

Mr. Ridgely, from the committee, delivers to the speaker a bill, entitled, An act to appoint commissioners to examine, survey and lay out, the several roads therein mentioned; which was read the first time and ordered to lie on the table.

On motion, Leave given to bring in a bill for the direction of surveyors in executing warrants of escheat in certain cases. ORDERED, That Mr. Key, Mr. Hall and Mr. Taney, be a committee to prepare and bring in the same.

The bill to lay out certain roads from Andrew Gore and James Cooper's mill, in Baltimore county, was read the second time, passed, and sent to the senate by the clerk.

Mr. Keene, from the committee, delivers to the speaker a bill, entitled, An act to authorize and empower the levy court of Dorchester county to assess and levy annually a sum of money for the support of John Button; which was read the first time and ordered to lie on the table.

The amendments to the bill to repair the public gaol in Saint-Mary's county, were read the second time, agreed to, and the bill ordered to be engrossed.

The bill to correct an error in a certain deed therein mentioned, was read the second time, passed, and sent to the senate by the clerk.

The report on the memorial of Vachel Stevens was read the second time, and the question put, That the house assent to the resolution therein contained? Determined in the negative.
