empowered to: demand and receive of the leveral proprietors, from time to time, the sums of money so ordered to be advanced de carrying on and executing, or repairing or keeping in order, the faid works, until the sums subscribed shall be fully paid, and to order the faid sums to be deposited in the hands of the treasurer, to be by him disbursed and paid out as the said president and directors, or a majority of them, shall order and direct; and if any of the said proprietors shall resuse or neglect to pay their faid proportions within one month after the time of payment fo ordered and advertifed as aforesaid, the faid president and directors, or a majority of them, may sell at auction, and convey to the purchaser, the share or shares of such proprietor to resuling or neglecting payment, giving at least three months notice of the fale in some of the Maryland, Delaware and Pennsylvania news-papers, and after retaining the fum due, and charges of fale, out of the money produced thereby, they shall refund and pay the overplus, if any, to the former owner; and if such fale shall not produce the full fum ordered and directed to be advanced as aforefaid, with the incidental charges, the faid prefident and directors, or a majority of them, may, in the name of the company, sue for and recover the balance by action of debt, or on the cafe; and the faid purchaser or purchasers shall be subject to the same rules and regulations as if the said sale and conveyance had been made by the original proprietor; provided, that in case of the death of any stockholder, the neglect or refusal of his executor, administrator or legatee, to make the payment that may be required as aforesaid, shall not have the effect to forfeit immediately the faid share or shares held by the faid stockholder in his life-time, but the faid executor, administrator or legatee, shall have one whole year next after the day of the faid death to make the payments required.

VI. And, to continue the fuccession of the faid president and directors, and to keep up the same number, BE IT ENACTED, That from time to time, upon the expiration of the faid term for which They may be the faid prefident and directors were appointed, the proprietors of the faid company, at the next continued, &c. general meeting, shall either continue the faid president and directors, or any of them, or choose others in their stead, and in case of the death, removal, resignation or incapacity, of the president, or any of the faid directors, may and shall, in manner aforesaid, elect any other person or persons to be president and directors in the room of him or them so dying, removing or resigning, or becoming incapable, and may, at any of their general meetings, remove the president, or any of the directors, and appoint others for and during the remainder of the term for which fuch person or persons were at first to have acted.

VII. AND BE IT ENACTED, That every president and director, before he acts as such, shall take To take an an oath, or affirmation, for the due execution of his office.

VIII. AND BE IT ENACTED, That the presence of proprietors having five hundred shares at the A general least shall be necessary to constitute a general meeting, and that there be a general meeting of proprictors on the first Monday of June in every year, at such convenient place as shall be from time to sec. time appointed by the faid general meeting; but if a fufficient number should not attend on that day, the proprietors who do attend may adjourn such meeting from time to time till a general meeting of proprietors shall be had, which may be continued from day to day until the business of the company is finished, at which meeting the president and directors shall make report, and render distinct and just accounts of all their proceedings, and on finding them fairly and justly stated, the proprietors then present, or a majority of them, shall give a certificate thereof, duplicate of which shall be entered on the said company's books; and at such yearly general meetings, after leaving in the hands of the treasurer such sum as the proprietors, or a majority of them, shall judge necessary for repairs and contingent-charges, an equal dividend of all the net profits arifing from the tolls hereby granted shall be ordered and made to and among all the proprietors of the faid company, in proportion to their feveral shares; provided nevertheless, that whenever the net profits arising from said tolls shall exceed thirty per cent. the faid prefident and directors shall account annually to and with the states of Maryland and Delaware for the furplus, and the same shall be equally divided between the said flates; and upon any emergency, in the interval between the faid yearly meetings, the faid prefident, or a majority of the faid directors, may appoint a general meeting of the proprietors of the said company at any convenient place, giving at least one month's previous notice in some of the Maryland, Delaware and Pennsylvania news-papers, which meeting may be adjourned and continued as aforefaid.
