Mr. SCHLEY, when his name was called, said :

It is proper I should explain my vote upon this amendment of the gentleman from Baltimore city (Mr. Stirling.) Upon the abstract proposition of the sale of the public works I am and have been for such sale; and whenever that proposition is presented in a

form acceptable to me, I shall vote for it. So that I cannot falsify my original position by voting at this time for the exemption of these works, I wish to say to the gentleman from Baltimore county (Mr. Ridgely) that whilst advocating the general principle of the sale of the public works, I am unwilling to accept the form in which the majority of the special committee have made their report, for reasons which I have already given. I endeavored by a proposition, which I will support, to make it more acceptable than it was. If that proposition be carried, then I shall support the proposition of the majority of that committee. But upon this proposition I am constrained to vote "no."

The question was next upon the portion of the amendment to the amendment excepting from sale the Susquehanna and Tide Water Canal.

Mr. MILLER called the yeas and nays upon this question, and they were ordered.
