

into account situations where a small county does not have enough eligibles. However, I think Judge Adkins, or Delegate Adkins has answered that correctly in his exchange with the Chairman of the Committee, and I urge that you vote against the Chabot amendment and support the Adkins amendment.

THE CHAIRMAN: Are you ready for the question?

(Call for the question.)

The question arises on the adoption—will the Clerk ring the quorum bell, please?

The question arises on the adoption of Amendment No. 25 as a substitute for Amendment No. 24. If Amendment No. 25 is adopted it will be substituted for 24 and submitted again to you for vote. If it fails, Amendment No. 24 would be submitted to you.

A vote Aye is a vote in favor of Amendment No. 25. A vote No is a vote against. Cast your votes.

Have all delegates voted?

(There was no response.)

Does any delegates desire to change his vote?

(There was no response.)

The Clerk will record the vote.

There being 16 votes in the affirmative and 117 in the negative, the motion is lost. Amendment No. 25 is not substituted for Amendment No. 24.

The question arises on the adoption of Amendment No. 24. Is there any further discussion?

(There was no response.)

Are you ready for the question?

(Call for the question.)

A vote Aye is a vote in favor of Amendment No. 24. A vote No is a vote against. Cast your vote.

Has every delegate voted?

(There was no response.)

Does any delegate desire to change his vote?

(There was no response.)

The Clerk will record the vote.

There being 117 votes in favor and 18 against, the motion is carried and the amendment is adopted.
