

A PROPOSAL that no extra compensation shall be granted or allowed by the General Assembly or received by any public officer, agent, servant, or contractor after the service has been rendered or the contract entered into; and that prohibits the increase, supplementation from any public source, or diminution of the remuneration or salary of any public officer, agent, or servant of the State during their term of office.

THE PRESIDENT: Delegate Proposal No. 102 is referred to the Committee on State Finance and Taxation.

Delegate Proposal No. 103. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 103, by Delegate Weidemeyer. Title,

A PROPOSAL that the percentage of income subject to levy by the State of Maryland be limited.

THE PRESIDENT: Delegate Proposal No. 103 is referred to the Committee on State Finance and Taxation.

Delegate Proposal No. 104. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 104, by Delegates Schneider and Siewierski. Title,

A PROPOSAL that the General Assembly shall be reapportioned in 1969 and every four years thereafter.

THE PRESIDENT: Delegate Proposal No. 104 is referred to the Committee on the Legislative Branch.

Delegate Proposal No. 105. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 105, by Delegate Mason. Title,

A PROPOSAL that to be eligible for nomination and appointment as judge, a person shall be a citizen of the State; shall have been a member of the bar of the State for at least five years immediately prior to his nomination; and shall be a resident of the circuit or district where the vacancy exists.

THE PRESIDENT: Delegate Proposal No. 105 is referred to the Committee on the Judicial Branch.

Delegate Proposal No. 106. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 106, by Delegates Byrnes, Cardin, Cha-

bot, Hutchinson, White, Dorothy Murray, Pascal, Schloeder, Soul, and Harry Taylor. Title,

A PROPOSAL that the right to vote shall not be abridged on account of religion, race, color, or sex.

THE PRESIDENT: Delegate Proposal No. 106 is referred to the Committee on Suffrage and Elections.

Delegate Proposal No. 107. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 107, by Delegates Grant and Gullett. Title,

A PROPOSAL that empowers the General Assembly to enact general public laws applying to all municipal corporations or all municipal corporations in a legislatively-established class.

THE PRESIDENT: Delegate Proposal No. 107 is referred to the Committee on Local Government.

The next item of business is motions and resolutions. Delegate Cardin?

DELEGATE CARDIN: Mr. Chairman, if I may, Proposal No. 106 was drafted by members of the Suffrage and Elections Committee. We would prefer that it be referred to the Committee on Bill of Rights and the Preamble.

THE PRESIDENT: I think the subject matter of the proposal is within the province of the Committee on Suffrage and Elections, Delegate Cardin. Is there some particular reason why it is desired that it be referred to the Committee on Personal Rights?

DELEGATE CARDIN: Perhaps because we discussed it, and we do comprise the Committee on Suffrage and Elections, and we wanted the Bill of Rights Committee to discuss it.

THE PRESIDENT: That can be accomplished in another way. Let me suggest that we not change reference now. I would like to discuss the matter after the session with you and any others.

DELEGATE CARDIN: Thank you.

THE PRESIDENT: I now have Resolution No. 3. It has been reproduced. I do not know whether copies have yet been circulated. Do you have a copy of Resolution No. 3 by Delegate Malkus on your desk? It has been reproduced. It will be circulated before the session is over. The Clerk will read the resolution.
