take it that since the sections governing the nominating commissions are the succeeding sections, that amendments pertaining thereto would be in order.

DELEGATE MALKUS: If you have so diagnosed that, Mr. President, I will feel very safe in preparing amendments and hopefully, of course, they will be considered. I want amendments establishing how these commissions are going to operate. It is late tonight, but if you say that tomorrow is time enough, then I will go ahead and rest my weary bones and have amendments ready by 10.00 A.M. tomorrow morning.

THE CHAIRMAN: The Chair's answer to your statement was only as to its generality. Any further questions?

The Chair recognizes Delegate Powers.
