There being 115 votes in the affirmative and 3 in the negative, the motion carries. The amendment is adopted.

Is there a further amendment to section 5.16, Mr. Clerk?

READING CLERK: Yes, sir.

THE CHAIRMAN: Let me have all the amendments to 5.16.

Delegate Mitchell, you had an amendment precisely the same as the one just offered. You do not desire to press it?

DELEGATE MITCHELL: I withdraw mine.

THE CHAIRMAN: Thank you.

Delegate Gill, you had amendment to the same effect, and you withdraw it?

DELEGATE GILL: Yes, I withdraw it.

THE CHAIRMAN: Are there any further amendments to 5.16?

The Chair hears none.

Are there any amendments to section 5.17?

Delegate Sollins, you have an amendment to 5.17. Do you desire to offer it?

DELEGATE SOLLINS: Yes, I do.

THE CHAIRMAN: Delegate Adkins, do you have one?

DELEGATE ADKINS: Yes.

THE CHAIRMAN: They are quite different. They were to be distributed separately.

The pages will please distribute Amendment BU. This will be Amendment No. 35.

For what purpose does Delegate Schloeder rise?

DELEGATE SCHLOEDER: I rise on a point of personal privilege.

THE CHAIRMAN: State the privilege.

DELEGATE SCHLOEDER: I would like the chamber to welcome thirty-five members of Gilman School who are here with their teachers, William Campbell and Robert Bloom.

I would also like us to welcome John Hargrove who is the son of Delegate John Hargrove; and Miloe Koger, the nephew of Delegate Earl Koger; and also Allan Moore, who is the nephew of Delegate Charles Wagandt.

THE CHAIRMAN: We are delighted to have them here.

(Applause.)

The Clerk will read Amendment No. 35.

READING CLERK: Amendment No. 35 to Committee Recommendation JB-1, by Delegate Sollins: On page 5 section 5.17, Lawyer Members of Nominating Commissions, in line 33 and 36 respectively after the word "elected" in each instance insert the words "by secret ballot."

THE CHAIRMAN: The amendment is proposed by Delegate Sollins. Is there a second?

(Whereupon, the motion was duly seconded.)

THE CHAIRMAN: The amendment having been seconded, the Chair recognizes Delegate Sollins to speak to the amendment.

DELEGATE SOLLINS: The amendment is self-explanatory. It shows that in choosing the lawyer members of the nominating commissions, it is a very sensitive position, that the election will be by a secret ballot. I have discussed this with Mr. Mudd. He is agreeable, and I will rest on that.

THE CHAIRMAN: Delegate Mudd.

DELEGATE MUDD: Mr. Chairman, I can confirm in substance what the proponent of the amendment has said. We have no opposition to the requirement that a poll be taken by secret ballot. We thought it was an unnecessary detail and could be required by rule if necessary, but we will not resist the amendment.

THE CHAIRMAN: Is there any further discussion?

(There was no response.)

Are you ready for the question?

(Call for the question.)

THE CHAIRMAN: The question arises on the adoption of Amendment No. 35 to Committee Recommendation JB-1.

A vote Aye is a vote in favor of Amendment No. 35. A vote No is a vote against. Cast your vote.

Has every delegate voted? Does any delegate desire to change his vote?

(There was no response.)

The Clerk will record the vote.

There being 108 votes in the affirmative and 8 in the negative, the motion carries. The amendment is adopted.
