A RESOLUTION expressing best wishes to the members of the Pennsylvania Constitutional Convention.

WHEREAS, Today, December 1, 1967, is the opening day of the Pennsylvania Constitutional Convention; and

WHEREAS, The writing of the Constitution is the preparation of the most fundamental statement of the rights of men and is the framing of the basic organization that the people wish to have to represent and to serve them; and

WHEREAS, The experiences of the Constitutional Convention of Maryland, meeting in Annapolis for nearly three months, have shown the delegates the great challenges faced by those chosen to develop fundamental law and of the great oppor-
