A PROPOSAL that the governor or the General Assembly be empowered to enter into agreements with the federal government and the governments of other states to conserve natural resources and to prevent erosion of land.

THE PRESIDENT: Delegate Proposal No. 232 is referred to the Committee on Local Government.

Although these two proposals, numbers 231 and 232 are referred to the Committee on Local Government, I request the Committee on the Executive Branch to take note of these proposals, because it was questionable which of the two committees it should be referred to.

For what purpose did Delegate Scanlan rise?

DELEGATE SCANLAN: It may seem incredible, but a number of my Delegates here do not have Delegate Proposal No. 232, and we would not want to miss it. (Applause.)

THE PRESIDENT: We will see that they are distributed.
