We want to be able to have the sponsors at least heard by the end of next week so that all matters before this committee can then be debated within the committee and reports sent to the floor or, where they are completely unfavorable, finally disposed of before the committee.

DELEGATE DULANY: Mr. President, the Committee on Public Information will meet today 15 minutes after adjournment, in the Baltimore City Delegation Room in the Shaw House.

DELEGATE GALLAGHER: Mr. President, the Committee on the Legislative Branch will meet approximately 15 minutes after this session to hear from Delegate Werner Fornos in connection with one of his proposals and tonight at 7:45 p.m. to take up the general question of apportionment of the number of legislators for districts and meet again tomorrow morning at 9:30 A.M.

THE PRESIDENT: Delegate Boyer.

DELEGATE BOYER: Mr. President, the Committee on General Provisions will continue its deliberations by hearing from some scheduled witnesses this afternoon at 5:00 P.M. We will hear from Senator and our esteemed Second Vice-President William James. ## PLENARY SESSION OCTOBER 10, 1967 — 2:00 P.M. PRESIDENT H. VERNON ENEY, PRESIDING
