

READING CLERK: Delegate Proposal No. 357, by Delegates Caldwell, Blair, Key and Ritter. Title,

*A PROPOSAL that the General Assembly shall establish disqualifications for voting by reason of mental incompetence or conviction of serious crime; that it may provide for the removal of such disqualifications; and that the voting privilege of any citizen disqualified from voting after conviction of serious crime shall be established or reestablished five years after the expiration of any sentence imposed as a result of said conviction whether the term is served in an institution or suspended.*

Delegate Proposal No. 358. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 358, by Delegates Carson, James, Peters, Rollins, Sybert, and Willis. Title,

*A PROPOSAL that all law in effect in the State immediately prior to the adoption of this Constitution, regardless of the source thereof, shall remain in effect unless inconsistent with the provisions of this Constitution, until changed in accordance therewith.*

Delegate Proposal No. 359. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 359, by Delegates Carson, James, Peters, Rollins, Sybert, and Willis. Title,

*A PROPOSAL that provides for the establishment of counties and municipal corporations; the continuance of existing governments thereof; their instruments of government, powers, and classifications; the establishment, powers, and financing of regional governments and intergovernmental authorities; and for intrastate intergovernmental agreements.*

Delegate Proposal No. 360. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 360, by Delegates Case, James, Rollins, and Willis. Title,

*A PROPOSAL that the budget bill shall become law when passed by both houses of the General Assembly and shall not be subject to veto by the governor; that if the budget bill shall not have been finally acted upon by the General Assembly ten days before the expiration of its regular session, the governor shall issue a proclamation extending the session until the passage of the budget bill and ten days thereafter; and that after such proclamation no other legislation except provision for the cost of the extended session can be finally passed by the General Assembly until the budget bill has been enacted.*

Delegate Proposal No. 361. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 361, by Delegate Lloyd Taylor. Title,

*A PROPOSAL that the right to vote shall be restored one year after the completion of sentence for conviction of a crime which carries as a consequence the loss of the right to vote.*

Delegate Proposal No. 362. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 362, by Delegate Anderson. Title,

*A PROPOSAL that the provisions of Article XVI of the present Constitution dealing with referendum shall be retained.*

READING CLERK: Delegate Proposal No. 363, by Delegates Hanson and Sollins. Title,

*A PROPOSAL that establishes a commission on salaries for constitutional officers to be composed of ten members appointed by the governor, with the advice and consent of the Senate, for five-year terms, the terms of two members expiring each year; that the commission shall recommend by January 30, 1969, and thereafter by January 30 of the third year following each general election, a schedule of salaries for officers created by the Constitution; and*
