that the question of calling a convention may be submitted to the voters at any time by the governor, by the General Assembly, or by a petition signed by a number of qualified voters equal to ten per cent of the total number of votes cast for governor in the most recent gubernationial election; that if the question of calling a convention shall not have been submitted to the voters of the State for a period of twenty years after the effective date of this Constitution or after a convention has been held, then it shall be submitted at the next general election; that there shall be a constitutional convention fifty years from the effective date of this Constitution unless a convention has been called prior to that time; that the governor shall appoint a commission to prepare for any convention called; that the General Assembly shall provide by law for the assembling of the convention, the election of delegates, the filling of vacancies in the position of delegate, and the appropriation of sufficient funds for the work of the convention; that the convention shall adopt its own rules of procedure; and that any proposal recommended by the convention for changing the Constitution shall be submitted to the voters for adoption, and shall be effective only if approved by the affirmative vote of a majority voting thereon.

A PROPOSAL that except as otherwise specifically provided for in the Constitution, the General Assembly may not enact

any public local laws and, except with respect to appropriations, may enact only public general laws which in their terms and in their effects apply without exception to all counties or to all counties in a class; provided, however, that special powers or exceptions needed in county jurisdictions are subject to public general law, the enactment of which is in effect under specific prevailing conditions as enumerated within the law; and that no county shall be exempt from any public general law applicable to counties in its class.
