

*A PROPOSAL that the General Assembly shall establish a commission on inter-governmental relations which, in addition to other powers and duties which the General Assembly may prescribe, shall have jurisdiction to resolve boundary disputes between counties and municipalities; to define the boundaries of new governmental units or authorities; to recommend to the General Assembly classifications of counties and municipalities; to report to and to advise the General Assembly and other appropriate officials of state, regional, county, municipal, or other local governments with respect to intergovernmental relationships and problems of the State, and the adequate performance of inter-governmental functions; and to make recommendations to the General Assembly concerning the establishment, incorporation, merger, dissolution, or alteration of the boundaries of local governments or authorities in the State.*

THE PRESIDENT: Delegate Proposal No. 385 is referred to the Committee on Local Government.

Delegate Proposal No. 386. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 386, by Delegate Grant. Title,

*A PROPOSAL that establishes procedures for the removal of a local elected official for disability, incompetency, or other failure to carry out the duties of the office, and that the governor shall appoint a person of the same political party as the original incumbent to fill the remainder of the term.*

THE PRESIDENT: Delegate Proposal No. 386 is referred to the Committee on Suffrage and Elections.

Delegate Proposal No. 387. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 387, by Delegates Raley and Case. Title,

*A PROPOSAL that a county may exercise any power, other than judicial power or the power to tax, or perform any function which is not denied to it by the Constitution, by its charter, or by a public general law which in its terms and in its effects is applicable to all counties or to all counties of the county's class, and which*

*has not been transferred exclusively to another governmental unit, and that the General Assembly may by law delegate to the counties any or all power of taxation.*

THE PRESIDENT: For what purpose does Delegate B. Miller arise?

DELEGATE B. MILLER: Mr. Chairman, the footnotes on 383 and 384 have been misplaced. They—each one should be on the other proposal.

THE PRESIDENT: I understand, Delegate Miller, that the footnote on Delegate Proposal No. 383 states that it amends Delegate Proposal No. 314; but should be on 384.

DELEGATE B. MILLER: Yes.

THE PRESIDENT: And the footnote on 384 referring to Delegate Proposal 311 should be on 383?

DELEGATE B. MILLER: Yes, sir.

THE PRESIDENT: I think the simplest thing would be to reprint and substitute and see that the pages make the substitution tomorrow.

Delegate Proposal No. 387 is referred to the Committee on State Finance and Taxation.

Delegate Proposal No. 394. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 394, by Delegates Fox, Adkins and Fornos. Title,

*A PROPOSAL that there shall be a subclassification for assessment of land devoted to agricultural or open space uses as defined by law.*

THE PRESIDENT: Delegate Proposal No. 394 is referred to the Committee on State Finance and Taxation.

Delegate Proposal No. 395. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 395, by Delegate Schloeder. Title,

*A PROPOSAL that no person shall be denied the right to teach or discuss any social, economic, or political problem by the state, officials, or any organized group.*

THE PRESIDENT: Delegate Proposal No. 395 is referred to the Committee on Personal Rights and the Preamble.

Delegate Proposal No. 396. The Clerk will read the proposal.
