There are, in addition on your desk, three memoranda by Delegate Finch accompanying Delegate Proposals No. 14, 148, and 150, and a memorandum by Delegates Freedlander and Gullett accompanying Delegate Proposal No. 397.

As I was about to say a moment ago, we seem to have reversed the trend of a few days ago, unfortunately, and now have not one, but twelve new proposals.

Before reading those, let me call to your attention that the committee recommendations for your convenience are printed on blue paper. We now have two of these, one introduced yesterday, and the Committee Recommendation SF-1 is being distributed by the pages at this moment.
