Delegate Proposal No. 425, by Delegate L. Taylor. Title,

[A PROPOSAL that the General Assembly shall have the power to enact laws to protect the people from loss of income or employment.] referred to the Committee on the Legislative Branch.

Delegate Proposal No. 426, by Delegate Fornos. Title,

[A PROPOSAL that municipal and councilmanic election districts shall be based on equal population as nearly as practicable.] referred to the Committee on Local Government. There is a memorandum accompanying Delegate Proposal No. 426 by Delegate Fornos.

Delegate Proposal No. 427, by Delegate Finch. Title,

[A PROPOSAL that no person shall be restricted from practicing a plurality of professions.] referred to the Committee on Personal Rights and the Preamble.

Delegate Proposal No. 428, by Delegate Finch. Title,

[A PROPOSAL that all amendments of the United States Constitution concerned with personal rights shall be incorporated in the Constitution.] referred to the Committee on Personal Rights and the Preamble.

Delegate Proposal No. 429, by Delegate Finch. Title,

[A PROPOSAL that strikes by public educators and persons connected with public safety and law enforcement shall be prohibited.] referred to the Committee on Personal Rights and the Preamble.

Delegate Proposal No. 430, by Delegate Finch. Title,

[A PROPOSAL that no law enforcement officer shall be advanced to a command position until said officer acquires an associate of arts degree.] referred to the Committee on the Executive Branch.

Delegate Proposal No. 431, by Delegate Finch. Title,

[A PROPOSAL that no person not legally designated as a professional person

shall be deprived of any non-professional employment through compulsory membership in any social, political, economic, fraternal, trade, or union organization.] referred to the Committee on Personal Rights and the Preamble.

Delegate Proposal No. 432, by Delegate Finch. Title,

[A PROPOSAL that the police power of the State shall be exercised over corporations, associations, partnerships, and individuals.] referred to the Committee on the Executive Branch.

Delegate Proposal No. 433, by Delegate Finch. Title,

[A PROPOSAL that nothing of value shall be received by any public official to lobby or exercise any influence with reference to any action to be taken on any proposed legislation.] referred to the Committee on the Legislative Branch.

Delegate Proposal No. 434, by Delegate Finch. Title,

[A PROPOSAL that the police power of the State shall not be used to permit any corporation, association, or organization to infringe the equal rights of citizens of the State.] referred to the Committee on Personal Rights and the Preamble.

[A PROPOSAL that the General Assembly shall provide the programs necessary to guarantee equality of educational opportunity to all the people of the State.] referred to the Committee on General Provisions.

[A PROPOSAL that the Preamble shall state that the people of the State of Maryland, grateful to Almighty God, establish this Constitution.] referred to the Committee on Personal Rights and the Preamble.
