

concurrent resolution of both houses of the legislature. We are asking for trouble. We are dealing with something where dotting of i's and crossing of t's is terribly important. When the staff got together on this section 14 and worked it out as carefully as they did, it was in order to establish that the rights and duties did move from the Board of Public Works to the new board of review, but the legislature has a perfect right to take from the board of review, and it should, those uninteresting, unimportant duties that Delegate Morgan referred to.

In the interest of a tidy document, in the interest of a document that is well thought out, carefully designed, and that is a mosaic that ought not to be broken up, I ask you to defeat this amendment.

THE CHAIRMAN: Is there any other discussion?

The question arises on the adoption of Amendment No. 8 to Committee Recommendation GP-13.

THE CHAIRMAN: Delegate Fornos, do you have a copy of your amendment?

DELEGATE FORNOS: Delegate Hardwicke does.

THE CHAIRMAN: Delegate Rybczynski, do you desire to offer your Amendment T?

DELEGATE RYBCZYNSKI: I understand, Mr. Chairman, that there is a similar amendment prepared by a female member of this Convention and frankly I would appreciate voting for her amendment if it is the same as mine.
