The Clerk will record the vote.

There being 101 votes in the affirmative and none in the negative, the motion is carried.

Section 30 as amended of the schedule of transitional provisions; sections 21, 22 and 23 as amended of the schedule of legislation as contained in Committee Recommendation GP-13, are approved.

The Chair recognizes Delegate Borom.

DELEGATE BOROM: Mr. Chairman, I move that the Committee of the Whole rise and report the adoption of section 30 as amended of the transitional provisions, and the adoption of sections 21, 22 and 23 as amended of the schedule of legislation of Committee Recommendations GP-13.

The Chair reports on behalf of the Committee of the Whole that it has had under consideration section 30 of the schedule of transitional provisions, and sections 21, 22 and 23 of the schedule of legislation of Committee Recommendation GP-13; that it has approved section 30 with amendments, and it has approved sections 21, 22 and 23 with amendments.
