A RESOLUTION of appreciation to Samuel Kirk and Son, Incorporated.

WHEREAS, Samuel Kirk and Son, Incorporated, as a public service, designed, executed and presented to the Convention at its opening session on September 12, 1967, a silver mace, intended to serve as a symbol of the sovereignty of the people of this State, and

WHEREAS, this mace has been placed upon the rostrum beside the President throughout the Convention, for the purpose of showing when the Convention was officially in session, and has served to remind the Convention of the trust reposed in it by the people of Maryland, and source of the responsibility given it.

READING CLERK: Resolution No. 31, by the President, and Delegates Tawes, J. Clark and James.

A RESOLUTION of appreciation to the State Department of Education.

WHEREAS, the Constitutional Convention of Maryland, desiring to interest the youth of the State of Maryland in the proceedings of the Convention and in its pur-

pose of improving state government, sought high school students to serve as pages for the Convention, and

WHEREAS, the State Department of Education, through the Superintendents of Schools of several of the counties of the State, nominated high school senior students to serve as pages for the Convention, and

WHEREAS, without exception, the persons who have acted as pages have rendered excellent service, and have contributed materially to the dispatch with the business of the Convention was conducted, by the willing and gracious acceptance of the many tasks requested of them.

I have discussed it with Delegate Pullen, who we all know is a former superintendent of education, and since this is going out to the Department of Education, historically we would not want it to go out with any grammatical error. If you will look on line 21, you say on 21 "to the dispatch with the business". The "with" should be followed by "which".

I have read all the other resolutions, so you will be safe in reading only the titles.

THE PRESIDENT: Is there consent to adding "which" after "with" in line 21?
