written and is in the hands of the chief of the pages.

THE CHAIRMAN: Are there any other amendments?

Delegate Barrick.

DELEGATE BARRICK: I have Amendment No. 13.

THE CHAIRMAN: May the Chair suggest then, in the interest of continuing discussion on matters that we can consider, that Delegate Wheatley withdraw his motion at the present time, and Delegate Schneider agree to postpone further consideration of his amendment until later in this session?

DELEGATE WHEATLEY: I so with-draw my motion.

DELEGATE SCHNEIDER: I so agree.

THE CHAIRMAN: Delegate Schneider, so that the journal may be clear, would you withdraw your amendment upon the Chair's assurance that you will have an opportunity to submit it again?

DELEGATE SCHNEIDER: Mr. Chairman, I withdraw this amendment, reserving the right to place it again at a later time.

THE CHAIRMAN: All right. Amendment No. 8 is withdrawn. It will retain its number. It will be considered again.

Are there any others?

Delegate Barrick.

DELEGATE BARRICK: I would like, Mr. Chairman, to propose Amendment No. 13 which has been printed but not distributed.

THE CHAIRMAN: Let us see if we can get copies. Let me correct the record. I referred in the previous statement to Amendment No. 8. This was not Delegate Schneider's amendment. Amendment No. 8 is not withdrawn.

DELEGATE SCHNEIDER: It is No. 10.

THE CHAIRMAN: Delegate Schneider's amendment would be No. 10.

DELEGATE BARRICK: This would be No. 11.

THE CHAIRMAN: No. 10.

The Chair recognizes Delegate Barrick.

DELEGATE BARRICK: Mr. Chairman, this would actually be Amendment No. 11, but it is numbered 13.

THE CHAIRMAN: Which was No. 11? Yours?

DELEGATE BARRICK: Mine will be No. 11, now No. 13.

THE CHAIRMAN: One that has been circulated as No. 13 is Amendment 11. The Clerk will read the amendment.

READING CLERK: Amendment No. 11 to Committee Recommendation GP-1, by Delegate Barrick: in line 15 on page 1 of Committee Recommendation GP-1 after the word "occur" insert "or has occurred."

THE CHAIRMAN: Is there a second?

(The motion was duly seconded.)

THE CHAIRMAN: The amendment is seconded. The Chair recognizes Delegate Barrick to speak to the amendment.

DELEGATE BARRICK: Mr. Chairman, the only purpose of this amendment is to take care of a situation where great destruction of life or property has occurred and the governor may wish to call in the militia to take care of the situation after the occurrence. As I read the proposal it takes care of the situation when it may occur, and this would take care of it after it has occurred. I think it is rather self-explanatory and should require very little debate.

THE CHAIRMAN: Is there any further discussion? Delegate Gallagher.

DELEGATE GALLAGHER: Mr. President, would the sponsor consider an additional substitute by way of further amendment, what in reality I also planned to offer. My suggestion would be, if he would consider it, to strike out the words "may occur" and in lieu thereof insert the words "threatened or may have occurred" be inserted.

THE CHAIRMAN: Delegate Barrick.

DELEGATE BARRICK: I think that accomplishes the same purpose I wish to accomplish. I would accept that. It is probably a little better language.

THE CHAIRMAN: Does the seconder accept the modification? The modification is instead of inserting the words "or has occurred" in place of the word "occur," insert the words "is threatened or may have occurred." Please mark your copy.

DELEGATE GALLAGHER: Mr. President.
