*A PROPOSAL that establishes a unified judicial system; the office of chief justice of the Supreme Court; the jurisdiction and composition of the Supreme Court, the Appellate Court, the Superior Court, and the District Court; commissioners of the District Court; selection, tenure, and removal of judges; the administration of the judicial system; clerks of court; and the rule-making power of the Supreme Court.*

*A PROPOSAL that establishes the power of the State to incur indebtedness for a public purpose in such manner and upon such terms and conditions as the General Assembly may prescribe by law; the terms for the gift or loan of state assets or credits; and the procedures for appropriation of money by a budget bill or a supplementary appropriation bill.*

*A PROPOSAL that establishes the authority of the General Assembly to establish counties and multi-county governmental units, including intergovernmental authorities and popularly elected regional representative governments; the powers of counties, regional governments, and intergovernmental authorities; the classification of counties as determined by the General Assembly; the general application of laws; the structure of county governments and provisions for alteration thereof; the terms for gift or loan or assets or credit of local governments; the authority of counties to establish municipal corporations; the continuance of existing county governments and municipal corporations; and the power*

*of governmental units to enter into intra-state intergovernmental agreements, except to the extent prohibited by law.*

*A PROPOSAL that establishes a state-wide system of free public schools; supervision of institutions of higher education by the boards thereof; the militia; the oath of office; impeachment of state officials by the House of Delegates; and trial by a special tribunal of ten judges appointed by the Supreme Court from among the judges of the State for persons impeached.*
