DELEGATE DELLA: As of today?

THE PRESIDENT: Effective as of today.

DELEGATE DELLA: Probably he could make the motion then.

THE PRESIDENT: Perhaps I should say a word about this. I sincerely trust that the answer to this question is going to be that the President has no discretion to exercise in excusing absences in that the Convention has little or no discretion. I say that because the requests already received for absences for one reason or another point out to me at least that it is almost impossible to draw a line as to what would be a justifiable excuse and what would not; but because of the explicit language of the Enabling Act, I think we ought to have this clarified very promptly.

Are there any other announcements?

THE PRESIDENT: If not, the Chair recognizes Delegate Powers.

DELEGATE POWERS: Mr. President, having been given a lesson in the proper use of the microphone, I move the adjournment to 2:00 P.M. tomorrow, Thursday, September 14.

PLENARY SESSION SEPTEMBER 14, 1967—2:00 P.M. PRESIDENT H. VERNON ENEY, PRESIDING

THE PRESIDENT: The Convention will come to order.
