READING CLERK: Amendment No. 20 to Committee Recommendation LB-1, by Delegate Storm: On page 2, in section 3.06, titled, Election of Legislators, line 39, strike out the words "from which he seeks" and insert in lieu thereof the words "in which he is a candidate for".

THE CHAIRMAN: Delegate Gallagher.

DELEGATE GALLAGHER: Mr. Chairman, I wonder if Delegate Storm would agree that probably the Committee on Style and Drafting could best address itself to this problem? I know what he seeks to do, and I certainly would not want to oppose, but I do think it is a question of terminology.

THE CHAIRMAN: The Chair would suggest that this would appear to be a kind of problem that is properly one for the Committee on Style, Drafting, and Arrangement.
