DELEGATE SCANLAN: I now move the committee's recommendation that a new Rule 28 [29] be added to the rules under which the substantive reports, reports of substantive committees must reach the Committee of the Whole by November 17, 1967.

DELEGATE CHABOT: As I said, I do not believe that we need these goals. I believe that Rule 30 [32], which permits the Convention to take any matter from any committee at any time that the Convention feels it ought to come before the Convention is sufficient. I feel that the provision of a specific date in Rule 28A [30] creates an unnecessary and probably, as the date approaches, quite inconvenient limitation on the consideration that the committees ought to give to the many proposals that are and will be put before them.
