*A PROPOSAL that there be an elected lieutenant governor.*

*A PROPOSAL that to be eligible as a senator or delegate a person shall be a qualified voter of the State; a resident of the State for at least two years, and of the legislative district which he may be chosen to represent, for at least one year; and that senators shall have attained twenty-five, and delegates twenty-one, years of age.*

*A PROPOSAL that a system of workmen's compensation and means of protection against the hazards of unemployment and disability may be established by law; that no person shall be denied employment or the right to join a labor organization on the grounds of race, color, or creed, or because of sex, age, or handicap where otherwise capable; that human labor is not a commodity or article of commerce; that the State shall secure the right of employees to bargain collectively through representatives of their own choosing; and that no workman in the employ of a contractor engaged in public work shall be paid less than the rate of wages prevailing in the same trade or occupation in the locality.*

*A PROPOSAL that in all administrative proceedings of state agencies, no person shall be subject to the same official for both prosecution and adjudication, nor be deprived of liberty or property unless by a prescribed mode of procedure; and that the accused or claimant shall have the right: to a speedy and public hearing by an impartial arbiter; to be informed of the nature and cause of the judgment or accusation; to be confronted with the evidence against him; and to have the benefit of technical assistance in preparing a defense.*
