

that the General Assembly shall be redistricted following each decennial census by the governor after considering the redistricting recommendations of a gubernatorially-appointed twenty-five-member board; that the governor's redistricting plan shall be promulgated in the manner provided for acts of the legislature, and shall have the force of law; and that the Supreme Court shall review the governor's redistricting plan and grant appropriate relief, upon the application of any qualified voter.

*A PROPOSAL that citizens of the United States who have attained the age of twenty years and meet other requirements, shall be qualified to vote.*

*A PROPOSAL that the State, its agencies, its political subdivisions, and charitable organizations shall not be granted immunity from suit.*

READING CLERK: Delegate Proposal No. 77, by Delegate Della. Title,

*A PROPOSAL that the General Assembly be prohibited from establishing taxes that are calculated on a retroactive basis.*

READING CLERK: Delegate Proposal No. 78, by Delegate Pascal. Title,

*A PROPOSAL that requires candidates for office and office-holders to make certain disclosures as to their financial worth and their financial dealings with any governmental body or agency to prohibit any conflict of interest with government.*

Delegate Proposal No. 79. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 79, by Delegate Hardwicke. Title,

*A PROPOSAL that universal human rights be protected including the rights to be free from fear, hunger, and want.*

Delegate Proposal No. 80. The Clerk will read the proposal.

READING CLERK: Delegate Proposal No. 80, by Delegates Henderson, Scanlan, and Smith. Title,

*A PROPOSAL that an accused shall have the right to trial by jury, but that the number of jurors required for conviction shall be prescribed by law.*
