The question arises on the motion to amend the calendar to permit the second report of the Committee on Rules, Credentials and Convention Budget to be received at this time. All those in favor, signify by saying Aye; contrary, No. The Ayes have it. It is so ordered.

Mr. Clerk, do you have the report?

I am informed that after the commentary was circulated yesterday, there was a change made in the last page, and a revised last page was placed on your desk. You should, therefore, have an additional unnumbered last page. You can tell it is the last page because it has the typed signature of the committee.

The Clerk will read the report.

READING CLERK: Second report of the Committee on Rules, Credentials and Convention Budget, dealing with lobbyists.

THE PRESIDENT: The report is received and referred to the Committee on Calendar and Agenda.

Are there any motions and resolutions, Mr. Clerk?

CHIEF CLERK: There are none, Mr. President.

THE PRESIDENT: Any motions or resolutions? If not, we will move to announcements.

I have been requested to announce, so that the delegates and the committee chairmen may know, that the staff meeting of all committee staff advisers and administrative assistants will be held on September 20, that is, Wednesday, at 2:00 P.M., in the office of the Chief of Staff, Room H-105, tomorrow at 2:00 P.M., for all committee staff advisers and committee administrative assistants.

Are there any announcements by committee chairmen? Delegate Sherbow?

DELEGATE SHERBOW: This being a historic occasion, I would like to report a first. The absence of Mr. Perry E. Darby is due to the fact that early this morning his wife gave birth to a little six and a half-pound girl.
